Biographical Sketch¹: Max Allen is a former CBC producer and a co-founder of the Textile Museum of Canada. Allen has been an activist against censorship since the 1970's and has been collecting material related to censorship and pornography since that time. Allen began collecting during his time working for the North America News which distributed published material that was considered by the standards of the day to be pornographic in nature. This material was censored by the Canadian government. Allen originally began collecting the material distributed by the North American News, but soon began to collect other material related to censorship and pornography.

Allen worked as a producer of the CBC Radio's *Ideas* program in the 1990's. *Ideas* was first broadcasted in 1965 and covers many social issues including culture and the arts, geopolitics, history, biography, science and technology and humanities. Most of the programs are documentaries, which Allen was greatly involved with. Although he produced many of the *Ideas* documentaries, his records illustrate that he performed a great amount of research on the programs on sexual issues such as pornography, child molestation and abuse, and censorship.

Custodial History: Max Allen officially donated his records to the University of Toronto in 2000 where they were housed at the Faculty of Physical Education under the care of Professor Brian Pronger. The records of Max Allen are now housed at University College, under the control of the Mark S. Bonham Centre for Sexual Diversity Studies.

¹ Some of the biographical history of Max Allen has been taken from the report done by Michelle Wilder and Allison Larsh in August of 2007 based on interviews with the creator.

Scope and Content: The records of Max Allen illustrate his research and work (both professional and personal) from the early 1960's through to 2002, The records reflect Allen's work as a producer, writer, curator, and activist. The fonds is mostly made up of textual material and includes court documents, anti-censorship cases and campaigns, internet fiction and newsgroup postings, erotic films and video catalogues, material related to child pornography and child abuse, short stories, manuscripts, comics, news paper clippings, some correspondence, exhibitions, workshops, and seminars. The fonds has some graphic material including photographs, pornography magazines and calendars. Also included are a film reel and ephemera.

Notes

Conservation: Original file jackets removed and replaced with acid free folders. Materials that were in binders were removed and placed into acid-free folders.

Arrangement: The records are physically arranged according to the original order in which they were received. The fonds has been intellectually organized into series based on the contents of the records and their relationships.

Restrictions: The SRC is a restricted access, non-circulating collection. Researchers can make an appointment to view materials by contacting the SRC Curator, and must sign the Agreement for Conducting Research with SRC. Materials are to be used on the premises only, under the supervision of the Curator or an appointed designate. Volunteers, SDS faculty, work-study and practicum students are in the process of creating catalogues and finding aids for various aspects of the collection. Researchers may inquire as to the current status and availability of existing documentation on particular topics of interest and we will make every effort to accommodate.

Terms governing use and reproduction: Reproduction requests can also be submitted to the SRC curator.

General note: Titles on original folders were utilized to the extent that they were able to adequately describe the contents of the file. When the title was not descriptive enough, the archivist imposed a new, more informative title.

Series 2: Various records relating to the John Young court case
