Background Information

These materials related to the Canadian Committee Against Customs Censorship were collected by CBC journalist Max Allen (a further collection of Allen's materials is also available). The documents are related to trials on pornography and obscenity, including *Glad Day v. Minister of National Revenue* (1991), regarding the import of *The Joy of Gay Sex*. This case started approximately 20 years of court cases for *Glad Day* over censorship. Explicit content was routinely seized at the border, preventing shipment to queer bookstores such as Toronto's *Glad Day* and Vancouver's *Little Sister*. The CCACC was formed in response to these seizures, lobbying against discriminatory censorship practices. The legal battles eventually ended in 2004 with *R v Glad Day Bookshops Inc*, regarding the distribution of lesbian magazine *Bad Attitude*, which ruled that restricting obscene materials violated the guarantee to freedom of expression in the Canadian Charter of Rights and Freedoms. This case was a win over anti-pornography advocates such as Catherine MacKinnon and Andrea Dworkin, who wanted stricter regulation. Allen's files cover a variety of cases related to pornography and explicit materials, including copies of the censored materials along with court records.
